- You have the right to ask us to correct your personal data if you notice that we are using incorrect ones.
- In some specific cases, you have the right to ask us to delete your personal data or to restrict the
  processing of your personal data. Please note that the processing of your personal being based on your
  consent, you may withdraw this consent at any time.
- You have the right to ask us to receive a copy of your personal data, in a structured, commonly used and machine-readable format and to transfer such copy to another entity, to the extent ANAFGROUP may technically carry out such transfer.
- You have the right to lodge a complaint with the supervisory authority responsible for data privacy in the country of your habitual residence, place of work or place of the alleged violation if you consider that the processing of your personal data by ANAFGROUP infringes these legal requirements.
